Behavioral Health Providers provide on-site assessment, solution-focused brief therapy, basic mental health consultations, and clinical support services to patients and their families using evidence-based best practices. They evaluate crisis situations and implement appropriate interventions. They recommend and implement care management processes that support an integrated healthcare model with the primary care team. This may include providing consultation and education to health clinic staff, regarding both emotional and behavioral issues, as well as effective interventions. Behavioral Health Providers serve as a liaison between patients, families, physicians, external facilities and agencies.

Job Responsibilities

Works with the primary care team to efficiently and effectively treat and manage high risk patients and those with chronic emotional or physical health concerns.

Provides short term individual therapy, using evidence based modalities (SBFT, MI, CBT) appropriate to primary care medical settings.

Provides mental health consultation, assessment and diagnosis as requested by the primary care team, including crisis intervention as needed.

Assists in primary care providers in recognizing mental health and psychosocial issues, and promoting interventions that support emotional health and wellbeing.

Supports screening and tracking of identified patient populations as determined by clinic initiatives (eg: substance use and depression registries, population based health initiatives).

Assesses patients to determine the appropriate level of mental health intervention, including triaging patients to specialty mental health services. This may also include responding to trauma and urgent psychiatric situations necessitating the writing of mental health holds.

Provides appropriate level of case management and referrals to community resources.

Supports the primary care team to develop patient care plans that target improvement in all biopsychosocial domains.

Provides psychoeducation to patients, families and staff on a variety of topics related to emotional health and wellbeing.

Participates in all required clinic and Community Reach Center training activities and meetings.

Behavioral Health Providers serve as a liaison between patients, families, physicians, external facilities and agencies.

Performs other such duties as assigned within the scope of the position and program description, as well as those reflective of their experience, education and ability.
